2. Cancellation. Chamber reserves the right to any event if it is deemed necessary. In the event of any such cancellation. Chamber will refund Sponsor's payment in full, and Sponsor shall waive any and all damages and claims for damages in connection with such cancellation.
3. Sponsor Cancellation. Sponsor may withdraw from the event and receive a full refund less a Fifty Dollar (\$50.00) administrative fee, sixty days (60) prior to the event.

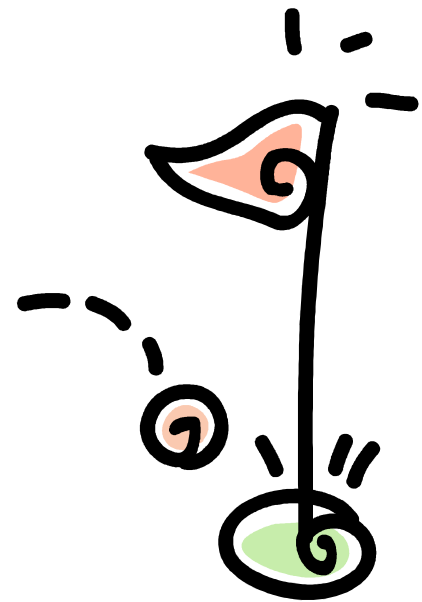
